### ***Interreligious dialogue and rights***

The Summer Course (from now on, *Summer Course*) with the theme "Interreligious dialogue and rights" (*Interreligious dialogue and rights*) is part of the initiatives of the Department of Law and is organized in collaboration with the Higher Institute of Sciences Religious of the Pontifical Theological Faculty "S. Giovanni Evangelista" and the "Peaceworkers" Association of Mazara del Vallo.

#### INTRODUCTION - KEY CONCEPT

The axis of the *Summer Course* consists of the dialogue interfaith, meaning the faith-based tool for the prevention and management of conflicts and ethnic and cultural wings that form the background to the current migration. The course is aimed at the acquisition of skills and abilities in the field of interaction between different religious approaches and the comparison between the legal systems of the religions of the Euro-Mediterranean area. In particular, it intends to offer a broad-spectrum perspective, which will allow participants to learn the relationship models between religions, cultures and confessional systems, with reference to specific common areas such as **jurisdiction and protection of rights, family and gender, financial systems, dietary rules**. In this perspective, similarities, differences, ways of carrying out the individual institutes common to Christianity, Islam and Judaism will be investigated with attention also to the tensions that, on these relevant topics, can arise between the various religious and ethnic-cultural communities present in the current social context, and the method for relating the different views and agevolar nor the *governance*.

#### **THEMES AND OBJECTIVES**

The *Summer Course* seeks to learn and investigate the dynamics of the comparison between systems legal religious, understanding what aspect relevant interreligious dialogue confessional and intercultural, helping to shape the problematic he related to social cohesion and *governance* differences. In particular, the course will focus on the following aspects :



- (1) Management and transformation of conflict on a religious basis: the dialogical approach between religious confessions;
- (2) Comparison between religions and confessional regulations of the Euro-Mediterranean area;
- (3) Similarities, differences, problematic aspects between common areas: jurisdiction and protection of rights, family and gender, finance and the market .

## METHODOLOGY

Two seminars will be held in each working day, which will address the challenges posed by the mass migration phenomenon, with the aim of studying the various issues involved.

In order to stimulate a more active participation, at the end of the seminar session, a "laboratory" is also planned for those enrolled in the *Summer Course* , aimed at developing and deepening the topics introduced and discussed during the seminars, with the intervention of operators of integration policies and of inter-religious dialogue actors.

## RECIPIENTS OF THE SUMMER COURSE AND ADMISSION PREREQUISITES

The recipients of the *Summer Course* , in accordance with the *University Regulations* , are students who have graduated according to the regulations in force prior to Ministerial Decree no. 509/99; three-year degree or specialist degree pursuant to Ministerial Decree no. 509/99; bachelor's degree or master's degree pursuant to Ministerial Decree no. 270/2004, and therefore also doctoral students, research doctors, postdocs, those who have achieved a I and II level Master, who are interested in the subject and are able to orient themselves within the disciplines involved in the course. **There are 30 places available** , and at least 15 will be selected among those who have obtained the degree from another University. If the number of places referred to in the reserve provided for in the previous paragraph is not filled, the remaining available may be allocated to students enrolled in single- cycle degree and master's degree courses who have already acquired at least 120 ECTS globally considered to come from the University of Palermo. . The course will not be activated if there are fewer than 10 registration requests. Each candidate must fill in an attached form at the end of this announcement, to which he must attach his own *curriculum vitae et studiorum* . If the number of applications presented is greater than the maximum number of places available, the



Scientific Committee will, on the basis of the *curricula*, make the appropriate selection, drawing up a ranking, after determining the judgment criteria. Should any of the admitted participants renounce the participation, upon notice, the ranking will be subject to the consequent postponement until exhaustion.

In addition, a further **10 extra places** will be provided for graduates from universities in Spain or from the Maghreb countries.

### GENERAL INFORMATION, CREDITS AND FINAL CERTIFICATE

The *Summer Course* is divided into two phases: **the first** of a preparatory type dedicated to the individual study of the texts made available to students on the Department website. The texts indicated by the teachers will be made available at least 2 weeks before the start of the second phase and include both theoretical or empirical essays, and jurisprudential decisions or institutional documents. **The second phase** consists of lectures and guided debates, in which students will be invited to discuss with the teachers on the basis of the texts studied. The invited teachers come from Italian and foreign universities. The *Summer Course* will be held in Trapani and Mazara del Vallo. As per the program attached to this announcement, the course hours range from 9 to 14 and from 15 to 19. Participants will have free access to the Library of the territorial center of Trapani, of the Episcopal Seminary of Mazara del Vallo, as well as to the other libraries of the Faculty of Law.

The attendance of the *Summer Course* week, including three days of individual study (based on texts indicated by the teachers and made available to students) and four of lectures and debates, is suitable for conferring a certificate of participation worth 6 ECTS credits (6 CFU). To this end, a final assessment of learning is foreseen. Furthermore, the achievement of the qualification is subject to attendance at least 90% of the scheduled hours.
