RESEARCH DOCTORATES - CALL FOR FOREIGN STUDENTS AND INTERNATIONAL DOCTORATES

The call for the public selection for the XXIV Cycle of Research Doctorate Courses – Academic Year 2010/2011 will be published in the Italian Official Gazette– “Competitive Exams”, on August 24th.

Foreign students may apply to participate to all courses provided for in “attachment 1”.

A certain amount of positions without grant is provided for; for these positions a specific ranking list will be drawn: these positions are better specified in attachment 1.

International Doctorate courses, regulated by the Articles 5, 6 and 7 below, follow the same rules of the above mentioned Call

Article 5

Admission Tests

Selection is based upon qualifications and examinations.

Examinations aim at ascertaining candidates' attitude towards scientific research.

Admission examinations consist of:

- Written test – (the duration, from 4 hrs minimum to 6 hrs will be defined by the examining Board);
- Interview, where the candidate will expose his/her research plan, already sent as an attachment to his/her application, related to the relevant Doctorate issues.

Candidates have also to demonstrate their fluency in a foreign language.

Candidates will be admitted to examinations upon presentation of a **valid identification document**.

Each Evaluation Board has 100 points at its disposal, distributed as follows:

1. **Written test** – maximum 40/100 points. Minimum pass mark is 28/40;
2. **interview** – maximum 40/100 points. Minimum pass mark is 28/40;
3. **qualifications** – maximum 20/100, distributed as follows:
 - graduation mark – 10 points maximum (1 point for each mark above 101/110 + 1 point for praise)
 - other qualifications – 10 points maximum (other degree, post-degree specialisation courses certifications, attendance to other courses, study periods within Italian and foreign scientific institutions, and anything else deemed useful to demonstrate study and research activities).

During the first meeting, the Examining Board will explicitly fix the criteria and modalities for the evaluation of qualifications, as well as for examination procedures.

Qualifications will be evaluated after the written test, and before the correction of relevant papers. Candidates will be considered eligible after passing both tests with the minimum pass mark.

Written examinations will take place between November 5th and November 25th, 2010.

The schedule of Written examinations, with the indication of the examination venues with respect to each doctorate course, will be published on 25th of October 2010, in the website of the University of Palermo:

<http://portale.unipa.it/amministrazione/arearicercasviluppo/formazioneperlaricerca/home/dottorati.html>, as well as on the official board of the University (piazza Marina, 61), and is to be considered, under all respects, as an official convocation of candidates.

Candidates will be convoked for the interview during the written test by the examination Board; interviews might also take place the day after written tests.

The list of candidates admitted to the interview, with the indication of the mark they obtained in the written test and of the evaluation of qualifications, will be published by the Board itself through the notice board of examination premises.

Interviews must in any case take place by december 10th, 2010.

Article 6

Admission tests for foreign candidates

All foreign candidates may participate to competitive selection.

Foreign candidates are exempted from the payment of participation fee for the competitive selection for research Doctorate courses (Rector's Decree nr 2609, 29/07/2010).

Foreign candidates participating to the selection for reserved or supernumerary positions, should make an explicit request in their application form if:

- 1) they apply for **positions reserved for foreign students (without grant)**, for which a specific list will be drawn;
- 2) they ask for **supernumerary positions**, (up to 50% of the positions in the relevant call), if eligible, in a dedicated list, (as per par.13, letter p of the Research Doctorate rules and regulations), after the qualified opinion of the Board of Doctorate Professors if:
 - they have been awarded by a grant financed by the Ministry of Foreign Affairs of the Italian Republic, or by their mother Country's government;
 - they come from Countries with which a specific intergovernmental agreement or an agreement with the University of Palermo exists, in any case without charges for the University of Palermo.

The selection of foreign candidates applying for Doctorates according with the points 1) and 2) above, will be carried out through the evaluation of qualifications, the presentation of a research plan and an interview. Qualifications will be evaluated by the Board before the interview.

The Examining Board will communicate **by e-mail** the dates of interviews to foreign candidates.

The Evaluation Board has 60 points at its disposal, distributed as follows:

- 1) **interview** – maximum 40/100 points. Minimum pass mark is 28/40;

- 2) **qualifications** – maximum 20/100, distributed as follows:
- graduation mark 10 points maximum (1 point for each mark above 101/110 + 1 point for praise)
 - other qualifications – 10 points maximum (other degree, post-degree specialisation courses certifications, attendance to other courses, study periods within Italian and foreign scientific institutions, and anything else deemed useful to demonstrate study and research activities).

Candidates applying for positions with grants (and not for the reserved positions), will follow the same selection process of Italian ones, as per Article 5 above.

Foreign candidates must also certify (self-certification as per D.P.R. 445/2000) the following requirements:

- a) they possess civil and political rights in their Country;
- b) they possess, excluding Italian citizenship, all other requirements provided for Italian citizens.
